Dependent: A person who is 65 years of age or older as of December 31, 2016, who resides in the applicant's household, and for whom the applicant is entitled to claim a personal exemption under and pursuant to the federal income tax laws.			
Family: One or more persons living in the same household who pool their various sources of income into one budget to achieve the effect of sharing the cost of providing for support of the group.			
Household: Includes all persons who occupy a group of rooms or single room which is regarded as a housing unit when it is occupied as separate living quarters, and when there is either:			
	 Direct access from the outside of the building or through a common hall; or Complete kitchen facilities for the exclusive use of the occupants. 		
Income:	Includes all money received during the year and available to be used to provide support for the family or household.		
Person:	son: An individual, but shall not include a company, partnership, joint venture, joint agreement, association (mutual or otherwise), corporation, estate, trust, business trust, receiver, or trustee appointed by state or federal court or otherwise, syndicate, the State of Oklahoma, any court, city, municipality, school district, or any other political subdivision of the State of Oklahoma or group or combination acting as a unit, in the plural or singular number.
